ALTERNATIVE METHOD OF CONTROL (166.20(a)(4))

- No registered pesticide for the proposed use.
- No alternative practice available.
- Registered alternative pesticide available.

Detailed explanation of why the pesticide(s) currently registered is (are):

- Not effective to the degree necessary to control emergency. (Field data or statement from qualified expert is necessary to substantiate claim).

Pesticide is not available in adequate quantities.

- Alternative practice available

Detailed explanation of why it is not feasible to employ the alternative practice to meet emergency.

EFFICACY OF USE PROPOSED UNDER SECTION 18 (166.20(a)(5))

- Data, a discussion of field trials, or other evidence which provided the basis for the conclusion that the proposed pesticide treatment will be effective in alleviating emergency.

RESIDUES IN FOOD (166.20(a)(6))

- If residues are expected in or on food; *grass*
 List food item(s) likely to contain residues.
 Estimate of maximum amount of residues likely to result.
 Source from which estimate is based.

- Residues are not expected in or on food;

grass grown for seed - not grazed first year
How long grazing restriction

DISCUSSION OF RISK INFORMATION (166.20(a)(7))

- Application addresses the potential risks to human health, endangered or threatened species, beneficial organisms and the environmental expected to result from the proposed use, together with references to data and other supporting information.

CO-ORDINATION WITH OTHER AFFECTED STATE/FEDERAL AGENCIES
(166.20(a)(8))

/ If the proposed use of the pesticide is likely to be of concern to other federal or state agencies, the application should indicate that such agencies have been contacted prior to submission and any comments will be forwarded to EPA.

NOTIFICATION OF REGISTRANT (166.20(a)(9))

/ Evidence that registrant has been notified of exemption request:

ENFORCEMENT PROGRAM (166.20(a)(10))

/ Prior to approval, the applicant shall provide explanation of the authority of the Applicant or related state or federal agencies for ensuring any special requirements imposed under the section 18 would be complied with.

REPEAT USES (166.20(a)(11))

SPECIFIC EXEMPTION (166.20(b))

A specific exemption may be authorized in an emergency condition to avert:

A significant economic loss. *\$63 million*

Application should address (as appropriate)

- Scientific and common name of pest given
- Discussion of events which brought about emergency.
- Historical net & gross revenues for the site
- Estimate of net & gross revenue for site
 - without section 18
 - with section 18

A significant risk to endangered/threatened species or beneficial organisms or the environment.

Application should address (as appropriate)

- Scientific and common name of pest given
- Discussion of events which brought about emergency.
- Discussion of the emergency

QUARANTINE EXEMPTION (166.20(c))

A quarantine exemption may be authorized in an emergency condition to control the introduction or spread of any pest new to or not theretofore known to be widely prevalent or distributed within and throughout the United States and its territories.

Application should address (as appropriate)

- Scientific/common name of the pest
- Origin of pest and means of introduction and spread if known.
- Anticipated impact of not controlling pest.
