**INTRODUCTION:**

The registrant, Syngenta Crop Protection, Inc., responded to our previous memorandum (Paul Horng; D262385; 8/AUG/00) by submitting additional product chemistry data in MRID # 455026-02 and ; the Confidential Statement of Formula (CSF), a basic formulation dated 14/AUG/01; to fulfill the data requirement for reregistration of the end-use product, Havoc Rodenticide Bait Pack Pellets with Bitrex, EPA Reg. No. 100-1056. The product was originally owned by Zeneca Ag Products. EPA Registration Number was 10182-340. It was acquired by Syngenta Crop Protection, Inc. on 23/FEB/2001.

**FINDINGS:**

1. The submitted data in MRID # 455026-02 satisfy the product chemistry data requirement Guidelines 62-3 (830-1800, Enforcement Analytical Method) and 63-17 (830-6317, Storage Stability). No additional data are required.
2. The submitted CSF, a basic formulation dated 14/AUG/01, has been filled out completely and correctly. The nominal concentration, upper limit, and lower limit of the active and inert ingredients in the CSF comply with the requirement of 40 CFR 158.175. All ingredients claimed in the CSF have been cleared for use in pesticide formulation. The CSF is acceptable.
3. Since the label requirements are still being developed, the Agency will request new labeling for these products when the Rodenticide Cluster RED document are amended. Label review related to product chemistry sections will be conducted until the Rodenticide Cluster RED has been amended. This product shares the same product name as the product with Registration No. 100-1053. The registrant must change this product's name.

**RECOMMENDATIONS:**

The registrant has satisfied all product chemistry data requirements for reregistration of this product. Once the Rodenticide Cluster RED has been amended, and the product label related to the product chemistry sections satisfy the new label requirements, the Agency will have no objection to the reregistration of the end-use product, Havoc Rodenticide Bait Pack Pellets with Bitrex, EPA Reg. No. 100-1056.
