






#### Recommendation

CBRS recommends that no additional data/information be required for Ciba-Geigy cyromazine technical (100-632) for purposes of compliance with the 1992 PCB/HCB DCI. CBRS further recommends that the Confidential Statement of Formula not be amended, because PCB and/or HCB were/was not detected in any of the 10 batches.
