3. In your "DIRECTIONS FOR USE", change "DIRECTIONS" to "APPLICATION DIRECTIONS".

Use on gladiolus, tulips, dahlias, crocus, tuberous rooted begonias, gloxinias, caladiums bulbs and other bulbs. Apply before storing.]

#### **DIRECTIONS:**

FOR PROTECTION OF ORNAMENTAL SHRUBS, TREES AND FRUIT TREES (NON-BEARING OR DORMANT) FROM RABBITS AND DEER: Shake well & stir before using. Apply when surface to be treated is dry and rain or snow is not expected for a few hours. This will allow film to set properly. Apply with paint brush, hand or pressure sprayer that will produce a coarse wet spray. Thoroughly wet tree trunk, bark, branches, twigs and foliage of trees or shrubs to be protected. Be sure to treat areas well above reach of animals keeping in mind that as snow deepens, the height animals reach increases. In the spring treat new growth (except bearing fruit trees) as necessary.

FOR PROTECTION OF GLADIOLUS AND OTHER BULBS FROM MOLES: Dilute 1 pint of Rabbit-Deer Repellent with 1 gallon water. Dry bulbs before treatment. Shake well. Coat bulbs well with solution by dipping. If bulbs are to be stored, spread out to dry.
