

Will not stain or leave only residue. Adjust spray applicator for coarse or fine spray as directed and apply directly from container. Spray surfaces only until wet, repeat as needed. Spot test surfaces and fabrics for color fastness before spraying.


**Pests Indoors:** Do not allow spray to contact food, feedstuffs and water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated. Remove pets and cover fish tanks before spraying and until sprays dry.

Cockroaches, Ants, Clover Miltes, Crickets, Firebrats, Silverfish and Spiders—Apply as a coarse spray and spot treat only localized areas where insects are found or normally occur including dark comers of rooms and closets: cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. Ants—apply to trails, around doors and windows and where these pests gain entrance. A period of 4—7 days is normally required for maximum effect on roaches.

Carpet Beetles — Thoroughly apply as a fine spray along baseboards and edges of carpeting, under carpeting, rugs and upholstery in closets and on shelving and places where seen or suspected until moist, not wet.

Fless & Brown Dog Ticks—Thoroughly apply as a fine spray for spot treatment to infested areas such as pet beds and resting quartem, nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Carpenter Ants: Adjust sprayer to deliver a coarse spray. Apply mixture around doors and windows, and other points of entry. Also spray into cracks and crevices or through small, newly drilled holes into wall voids where ants or their nests are suspected.


Wood-Infesting Beetles: (Lyctidae, Bostrichidae, Anobiidae and Cerambycidae). To protect wood and control damage by these wood-infesting insects, apply mixture to wood using a coarse spray to the point of run-off.

Peets Out-of-Doore: Ants, Brown Dog Ticks, Crickets, Fleas, Earwigs—Treat localized infestations of these insects by thoroughly spraying weeds or brushy noncrop areas, shrubs, grass, or wherever these pests are found. Repeat as necessary. Ants—thoroughly wet hills and runways.

Files, Mosquitoes, Spiders—For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. Repeat as necessary.
