The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the permethrin and piperonyl butoxide REDs, and has concluded that your submission is acceptable.

NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.


Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

A copy of your label stamped "Accepted" is enclosed along with copies of the acute toxicity and product chemistry reviews completed for the subject product. 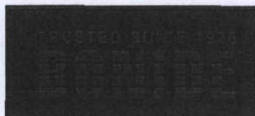

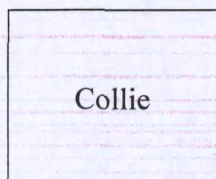

**ENVIRONMENTAL HAZARDS**

This pesticide is toxic to aquatic organisms, including fish and invertebrates. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area. Rinsing application equipment over the treated area will help avoid run off to water bodies or drainage systems.

**STORAGE AND DISPOSAL**

**Pesticide Storage:** Store and transport in an upright position. Store in a cool dry area inaccessible to children or pets.

**Pesticide/Container Disposal:** *If partly filled* – Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain. *If empty* – Nonrefillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available.

SHAKE WELL BEFORE USE.

**Precautions and Restrictions**

Remove pets, birds and cover fish aquaria before room applications are made. Except when applying directly to pets, do not allow adults, children, or pets to enter until sprays have dried. Do not wet bedding to the point of runoff or drip. Do not use treated bedding until spray has dried. Remove or cover exposed food and drinking water before application. Remove

or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before reuse.

Do not apply directly into sewers or drains, or to any area like a gutter where drainage to storm sewers, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

**READ ENTIRE LABEL BEFORE EACH USE. USE ONLY ON DOGS OR CATS.** Do not repeat treatment for seven (7) days. Do not use on puppies or kittens under twelve (12) weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant, nursing or medicated animals.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

**DOGS AND CATS:** Dilute at the rate of 3 fluid ounces in 1 gallon of water. For rapid control of *Ticks, Fleas* and *Lice*, sponge or dip solution on entire animal, thoroughly wetting the skin. Avoid contact with pet's face, eyes and genitalia.

**FOR RAPID CONTROL OF TICKS, FLEAS AND LICE WITH A MIST SPRAY:** Dilute at the rate of 1 fluid ounce in 9 fluid ounces of water. To insure thorough coverage, part the fur by stroking against the lay of the hair as spray is applied. Spray ticks directly. Apply to moisten the fur lightly.

In case of an emergency, call 1-800-548-2423 (Animal Poison Control Center).

**TO CONTROL INSECTS IN HOME KENNELS AND ANIMAL QUARTERS:** Dilute at the rate of 2 fluid ounces in 20 fluid ounces of water. Do not apply more than 8.6 fluid ounces of undiluted product per 1,000 square feet of area treated. Remove pets before treating the area and ventilate thoroughly before allowing them to re-enter the treated area. Not for use as a broadcast or space spray, for use as a crack and crevice spray only.

For rapid clean out of *Fleas* and *Ticks* in home kennels, adjust sprayer nozzle to deliver coarse droplets. Apply with special attention to cracks and crevices and other insect hiding places. Bedding should be removed and sprayed. To prevent recurrence of fleas, a total management program is recommended.
