HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION:** Harmful if absorbed through the skin or inhaled. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling. Wash exposed clothing before reuse. Do not contaminate feed, water or foodstuffs. Cover fish aquariums before use.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

<b>STORAGE AND DISPOSAL</b>
<p><b>Storage:</b> Store and transport in an upright position. Store in a cool dry area inaccessible to children or pets.</p> <p><b>Disposal:</b> <i>If empty</i> – Do not reuse this container. Place in trash or offer for recycling if available. <i>If partly filled</i> – Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.</p>

**DIRECTIONS:** Shake well before using. For use on carpets, hold upside down and shake powder evenly across surface. Brush lightly with a broom to allow powder to penetrate carpet fibers. Wait 60 minutes then vacuum. For severe problems or where ticks are known to be hiding, wait 2-3 hours before vacuuming. If powder adheres to a spot, brush it out and vacuum

immediately. Apply to dry surfaces only. Do not allow powder to become wet. For use on upholstery, remove all loose cushions. Sprinkle along creases, in corners. Brush gently, wait 60 minutes, vacuum. Sprinkle along underside of furniture. Do not use on exposed fabric: may cause staining. Remove bag from vacuum cleaner. Wrap securely in layers of newspaper and discard in trash.

\*Test hidden surface of upholstery before cleaning. If texture or color is affected, do not use.

Keep people and pets off treated carpet and upholstered furniture during treatment and until area is vacuumed.

Clean carpet AFTER using this product.

BEDBUGS: Dismantle beds completely and dust all parts thoroughly, including mattress seams and box springs. Dust all baseboards and wall cracks thoroughly. Repeat as needed.

FOR CONTROL OF LICE ON POULTRY & PET BIRDS: Dust the powder carefully into the feathers, under the wings, along the back and around the vent. Rub into feathers of head. Nests, roosts and runways, porches and cages should be thoroughly dusted. Destroy infested food or cuttlebone. Repeat as needed.

FLEAS ON GERBILS, HAMSTERS AND WHITE MICE: Do not use if female is pregnant or nursing young. Dust the powder onto the animal's hair and work it down to the skin. After treatment, brush or comb the animal's coat to remove dead fleas and lice. Repeat as needed.

READ ENTIRE LABEL BEFORE EACH USE. USE ONLY ON DOGS & CATS.  
Do not repeat treatment for 7 days. Do not use on puppies or kittens under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant, nursing or medicated animals.

FLEAS, LICE AND BROWN DOG TICKS ON CATS & DOGS: Dust the powder onto the animal's hair and work it down to the skin. After treatment, brush or comb the animal's coat to remove dead fleas and lice.
