The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cyromazine Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. Conduct germination tests on a small portion of seed before committing the total seed lot to a selected seed treatment. Treat using equipment similar to that planned for treating the total seed lot. Due to seed quality and seed storage conditions beyond the control of Syngenta, no claims are made to guarantee the germination of carry-over onion seed.

Treated seeds exposed on soil surface may be hazardous to wildlife. Cover or collect treated seeds that are spilled during loading and in areas such as row ends.

RESISTANCE MANAGEMENT

CYROMAZINE GROUP 17 INSECTICIDE

Trigard OMC contains cyromazine, a Group 17 insecticide. Cyromazine belongs to the cyromazine class of chemistry which disrupts dipteran molting. This mode of action is incompletely defined.

Insect populations may contain individuals naturally resistant to Group 17 insecticides and if used repeatedly in the same fields, then resistant members may eventually dominate the population. Because resistance development cannot be predicted, use sound resistance management strategies established for the crop and use area.

Base seed treatment on an integrated pest management program that includes field sanitation, historical information related to pesticide use, careful selection of pest-tolerant crop varieties, scouting, and management practices which optimize populations of natural enemies of insect pests such as within-field refugia (untreated areas). Sound management programs also consider cultural and biological control practices.

In order to maintain susceptibility to this class of chemistry:

• Use products at their full, recommended doses.

- Use appropriate, well-maintained equipment. Use recommended water volumes and apply at optimal temperatures in order to obtain optimal treatment.
- When rate ranges are given, use the higher rate within the listed rate range when insect pressure is expected to be high.
- Avoid using a single active ingredient or mode of action (same insecticide group) exclusively for season long control of insect species with more than one generation per crop season.
- For insect species with successive or overlapping generations, use a treatment window approach. A treatment window is a period of time defined by the stage of crop development and the biology of the pests of concern. Within the treatment window, depending on the length of residual activity, single or consecutive applications may be made using seed, in-furrow, or foliar treatments unless otherwise excluded by product labels. Do not exceed the maximum amount of this insecticide's mode of action allowed per growing season.
- Following a treatment window of this insecticide's mode of action, rotate to a treatment window of effective products with a different mode of action before making additional applications of this insecticide.

If resistance to this product develops in your area, this product or other products with a similar mode of action may not provide adequate control. If poor performance cannot be attributed to improper application or weather conditions, a resistant strain of insect may be present. If you experience difficulty with control and resistance is a reasonable cause, immediately consult your local company representative or agricultural advisor for the best alternative method of control for the crop and use area.

MIXING PROCEDURES

Thoroughly clean equipment before using this product. Utilize standard seed treatment equipment designed to apply wettable powders to seed and provide uniform seed coverage. Uneven or incomplete seed coverage may not give the desired level of insect control. Use an EPA-approved dye or colorant that imparts an unnatural color to the seed as stated in 40 CFR 153.155(c).

ROTATIONAL CROPS

The following plant-back intervals must be observed when planting rotational crops after planting seed treated with Trigard OMC.

SEED CONTAINER LABEL REQUIREMENTS

The Federal Seed Act requires that containers of treated seeds be labeled with the following statements:

- This seed has been treated with cyromazine insect growth regulator.
- Do not use for feed, food, or oil purposes.

In addition, the U.S. Environmental Protection Agency requires the following statements on containers of seeds treated with Trigard OMC:

- Store away from feeds and foodstuffs.
- Do not allow children, pets, or livestock to have access to treated seed.
- Groundwater Advisory: A degradate of Cyromazine is known to leach through soil into groundwater under certain conditions as a result of label use. This chemical may leach into groundwater if used in areas where soils are permeable, particularly where the water table is shallow.
- Wear long-sleeved shirt, long pants and chemical-resistant gloves when handling treated seed.
- Treated seed must be planted into the soil at a depth of at least ¼ inch.
- Treated seeds exposed on soil surface may be hazardous to wildlife. Cover or collect treated seeds that are spilled during loading and in areas such as row ends.

- Dispose of all excess treated seed. Leftover treated seed may be double-sown around the headland or buried away from water sources in accordance with local requirements.
- Do not contaminate water bodies when disposing of planting equipment washwaters.
- Excess treated seed may be used for ethanol production only if (1) by-products are not used for livestock feed, and (2) no measurable residues of pesticide remain in the ethanol by-products that are used in agronomic practice.

BULB ONIONS

Trigard OMC is a 75% wettable powder which, when applied to seed according to the following directions for use, will control onion maggots on bulb vegetables. Apply Trigard OMC to seed at the rate of 6.6 lb of product per 100 lb of seed (4.95 lb cyromazine per 100 lb of seed).

Treated seeds exposed on soil surface may be hazardous to wildlife. Cover or collect treated seeds that are spilled during loading and in areas such as row ends. Dispose of all excess treated seed and seed packaging by burial away from bodies of water.

Use Restrictions

- Do not apply concurrent applications at planting time of insecticide products which have activity against onion maggot.
- Do not harvest bulb vegetables grown from seed treated with Trigard OMC within 60 days of planting.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage and Disposal

Store in a cool, dry place. Do not use in animal feeds. Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

Pesticide Disposal

Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.

Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

Container Handling [bags]

Non-refillable container. Do not reuse or refill this container. Completely empty bag into application equipment. Then offer for recycling if available or dispose of empty bag in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

Container Handling [fiber drums with liners]

Non-refillable container. Do not reuse or refill this container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then offer for recycling if available or dispose of liner in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities. If drum is contaminated and cannot be reused, dispose of it in a manner required by its liner.
