- 3. Submit to the Agency, data on one year storage stability testing (830.6317), and corrosion characteristics study (830-6320) at 0, 3, 6, 9 and 12 months of warehouse storage.
- 4. Submit two (2) copies of the revised final printed label bearing the above stated revisions prior to releasing this product for sale.
