The application referred to above, submitted under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable under FIFRA sec 3 (c)(5). After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. 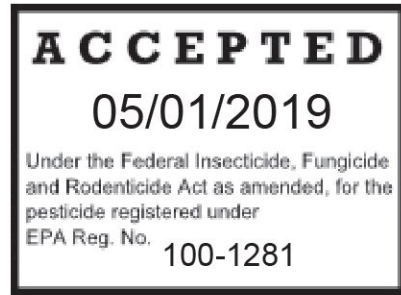

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is for formulation into an end-use fungicide.

Only for formulation into a fungicide for the following use(s): (1) basil (fresh and dried); bean, edible podded, including asparagus bean, catjang bean, Chinese longbean, cowpea, French bean, garden bean, goa bean, guar bean, green bean, jackbean, kidney bean, lablab bean, moth bean, mung bean, navy bean, rice bean, scarlet runner bean, snap bean, sword bean, urd bean, vegetable soybean, velvet bean, wax bean, winged bean, and yardlong bean; brassica, head and stem crop group 5-16; bulb vegetables; celtuce; citrus crop group 10-10; cucurbits crop group 9; Florence fennel; fruiting vegetables crop group 8; ginseng; grapes; hops; Kohlrabi; leaf petiole vegetables crop (subgroup 22B); leafy vegetable crop group (subgroup 4-16A & B); potato seed treatment; tobacco; tomatoes (field and greenhouse); and tuberous and corm vegetables crop (subgroup 1C); (2) outdoor and greenhouse grown ornamentals; (3) uses for which U.S. EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration; and (4) uses for experimental purposes that are in compliance with U.S. EPA regulations.

This product may be used to formulate products for specific uses not listed on the MP label if the formulator, user group, or grower has complied with U.S. EPA data submission requirements regarding support of such uses.

## **STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage and disposal.

### **Pesticide Storage**

Store in original containers only. Store in a cool, dry place. Keep container closed when not in use. Do not store near food or feed.

### **Pesticide Disposal**

Pour rinsate into formulation equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

### **Container Handling [bags]**

**Non-refillable container.** Do not reuse or refill this container. Completely empty bag into formulation equipment. Then offer for recycling if available or dispose of empty bag in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities.

### **Container Handling [fiber drums with liners]**

**Non-refillable container.** Do not reuse or refill this container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into formulation equipment. Then offer for recycling if available or dispose of liner in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities. If drum is contaminated and cannot be reused, dispose of it in the manner required for its liner.
