Dear Ms. Clark:

Consistent with FIFRA section 6(f)(1)(D), EPA approves Syngenta's request for voluntary cancellation of four products: A16901B Ornamental Insecticide (Reg. No. 100-1422), HGW86 T&O Insect Control (Reg. No. 100-1544), Mainspring (Reg. No. 100-1552), and Mainspring Flora GH (Reg. No. 100-1574). EPA notified the public of its receipt of these requests to voluntary cancellation in the *Federal Register* on Aug. 31, 2023, and provided a 30-day public comment period as required by FIFRA section 6(f)(1)(B). EPA received one anonymous comment on this notice that was supportive of EPA cancelling these registrations, which EPA acknowledges.

This letter serves as a cancellation order for these four products. Any distribution, sale, or use of existing stocks of the canceled product in a manner inconsistent with any of the existing stocks provisions set forth below will be considered a violation of FIFRA section 12(a)(2)(K). Although EPA is allowing certain sale, distribution, and use of existing stocks of the registration subject to this cancellation order, the Agency retains the right to amend the order, if circumstances warrant.

Based on Syngenta's representation that they hold no existing stocks, EPA is not providing Syngenta with a period to sell or distribute these products following this cancellation order. For purposes of this order, existing stocks are those stocks of pesticide products that are currently in the United States and were packaged, labeled, and released for shipment prior to this cancellation order on October 3, 2023.

This cancellation order includes the following existing stock provisions:

Persons other than the registrant may continue to sell or distribute existing stocks of EPA Registration Nos. 100-1422, 100-1544, 100-1552, and 100-1574 until supplies are exhausted, provided that the products contain the appropriate, previously approved labeling.

Any person may continue using existing stocks of the cancelled products until supplies are exhausted, provided that such use is consistent with the terms of the previously approved labeling of the cancelled products.
