# DIRECTIONS FOR USE

CAPBAGE, BROCCOLI, AND BRUSSELS SPROUTS: To control Army Worm, Cabbage Worm, Cabbage Looper, Climbing and Surface-Feeding Cutworms and Aphids—Apply at the rate of 10 lbs. per acre. Do not apply to cabbage after the heads begin to form. Do not apply to Broccoli and Brussels Sprouts after the edible parts begin to form.

COLLARDS AND KALE: To control Army Worm, Cabbage Worm, Cabbage Looper, Climbing and Surface-Feeding Cut orms and Aphids—Apply at the rate of 10 to 20 lbs, per acre, Do not apply more than 1 times nor more than 3 times after thinning. Do not apply within 11 days of harvest when 10 lbs, per acre is used, nor within 21 days of harvest when 20 lbs, per acre is used.

TOMATOES: To control Tomato Hornworm Tomato Fruit Worm, Sespentine Leaf Miner. Flea Beetle, Cabbage Looper, Blister Beetle and Aphids- Apply at the rate of 20 lbs. per acre. Do not apply within 10 days of harvest.
