FIRST AID TREATMENT — ANTIDOTE

SYMPTOMS OF POISONING: Excessive Fatigue. Sweating, Thirst and Fever. If symptoms of poisoning develop from any type of exposure, SEND FOR A PHYSICIAN.

FIRST AID: Have patient lie quiet in coolest spot available. If feverish, cool with cold compresses or by immersion in cool water. If Swallowed, SEND FOR A PHYSICIAN, Induce vomiting by giving an emetic such as 2 tablespoonfuls of table salt in a glass of warm water; repeat until vomit fluid is clear, then give two tablespoonfuls of baking soda in a glass of water. Treat as FIRST AID, above. If Splashed in Eyes, immediately flush eyes with plenty of water for a least 15 minutes and get medical attention. If Spilled On Skin, immediately remove contaminated clothing, including shoes, and wash with soap and plenty of water. If symptoms of poisoning develop, send for a physician and treat as in FIRST AID, above. Discard contaminated clothing and shoes, or clean them thoroughly before re-use. NOTE TO ATTENDING PHYSICIAN: Active ingredient is a metabolic stimulant. Treat symptomatically.

Do not contaminate water used for irrigation or domestic purposes Do not store near fertilizers, seeds, insecticides or fungicides. Thoroughly clean equipment used with this product with a suitable chemical cleaner before use for other purposes.

Do not reuse empty drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place away from water supplies.
