Subject: Amendment: Add restrictions per Agency pyrethroid labeling letter dated June 4, 2009,  
Update per PR Notices 2000-5, 2007-1 and 2008-1, and Revise Warranty section  
Atera 0.18 LC Fertilizer Insecticide  
EPA Reg. No. 228-583  
Your submission dated September 3, 2010

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) section 3(c)(7)(a), is acceptable provided the following revisions are made prior to release for shipment under the amended labeling:

- 1) On page 2, under the heading DIRECTIONS FOR USE, after "Apply using ground equipment only; do not apply by air." add as the next two lines "Do not make applications during rain. Do not water the treated area to the point of runoff."
- 2) In the Application Instructions, in the third sentence of the second paragraph revise "highest rates suggested" to "highest rate specified".
- 3) On page 5, at the end of the Imported Fire Ants entry add "Food utensils such as measuring cups must not be used for food purposes after use in measuring pesticides."
- 4) Since this is a ready-to-use non-dilutable granular product, there is no requirement for residue removal when packaged in nonrefillable containers (see PR Notice 2007-4 page 4, item III B ii). Therefore, replace the nonrefillable plastic container section (including the "5 gallons or less" and the "larger than 5 gallons" triple rinse directions sections) with the following:  
"CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. Completely empty container into application equipment, then offer for recycling, if available, or dispose of empty container in a sanitary landfill or by incineration. Do not burn unless permitted by state and local ordinance. If burned, stay out of smoke." Alternately, if plastic non-refillable containers will not be used for this product, then you can delete those directions. The remainder of the new Container Disposal directions may appear as proposed.

A stamped copy of the label is enclosed for your records. Please submit two copies of the revised amended labeling prior to release for shipment.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on nonrefillable containers. The code may appear either on the label (and can be added by non-notification/PR Notice 98-10) or durably marked on the container itself.

This product is extremely toxic to fish and aquatic invertebrates. Drift and runoff may be hazardous to aquatic organisms in neighboring areas. Do not apply where runoff is likely to occur. **PRODUCT INFORMATION**

The use of this product will provide plant nutrients as well being a long lasting contact and systemic insecticide for control of insects infesting lawns and surrounding areas. This product can be used around residences, business complexes, industrial complexes, airports, playgrounds, school yards, parks and recreation areas, athletic fields, cemeteries, arboretums, and non-production greenhouses.

Do not apply more than 250 pounds of product (0.25 lb of imidacloprid, 0.2 bifenthrin) per acre per year on residential use sites (i.e. around private homes, apartment buildings, condominiums, non-agricultural outbuildings, non-commercial greenhouses, pre-schools or day care facilities). Apply up to 500 pounds of product (0.5 lb of imidacloprid, 0.4 lb of bifenthrin) per application on non-residential use sites (i.e. around institutional, public, commercial or industrial buildings, parks, recreational area or athletic fields).

**RESISTANCE MANAGEMENT**

The active ingredients in this product are imidacloprid, a Group 4A insecticide, and bifenthrin a Group 3 insecticide. Insect biotypes with acquired resistance to Group 4A and Group 3 insecticides may eventually dominate the insect population if Group 4A or Group 3 insecticides are used alone or repeatedly in the same field or in successive years as the primary method of control for targeted species. Previous extensive use of Group 4 or Group 3 insecticides in a given area may result in resistance to selected target insects. This may result in partial or total loss of control of those species by this product.

To delay insecticide resistance in insects that are at risk of developing resistance to insecticides consider:

- Avoid the consecutive use of other Group 3 or Group 4A insecticides on the same insect species.
- Use tank-mixtures or pre-mixes of insecticides from a different target site of action group as long as both products are registered for the same use.
- Base insecticide use on a comprehensive IPM program.
- Monitor treated insect populations for loss of field efficacy.
- Contact your State Agricultural Experiment Station, State Extension Specialists, or other lawn experts and/or Nufarm Americas Inc. for insecticide resistance management and/or IPM recommendations for the specific site and resistant pest problems.

**APPLICATION EQUIPMENT**

Apply this product uniformly over the area being treated with normally used granular application equipment. Use either drop-type or rotary-type spreaders to apply this product.

Avoid the use of spreaders which would apply the material in narrow, concentrated bands. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly and accurately. To insure continued delivery of the correct amount of this product, make adjustments to the settings periodically during application.

**APPLICATION INSTRUCTIONS**

**LAWNS AND LAWN PERIMETERS**

Use this product to provide nutrients and for broad spectrum insect control in lawns, lawn perimeters, and landscaped areas. This product can be used around residences, business complexes, industrial complexes, airports, playgrounds, school yards, parks and recreation areas, athletic fields, cemeteries and other similar areas.

This product has sufficient contact and residual activity to provide high levels of control. Base the need for an application on historical monitoring of the presence of or anticipated occurrence of individual or multiple insect pest species, the site, previous records or experiences, current season adult trapping or other methods. Where multiple pests are present or anticipated, use the highest rates suggested to control the species that are present. Optimum control of white grubs, will be achieved when applications are made just prior to egg laying or to early instar larvae of target pests, followed by sufficient irrigation or rainfall to move the active ingredient into the zone where the insect pests are active. Use specified higher rates when long residual control is desired or late season curative applications are made to turf already showing grub damage.

Consult your local State Agricultural Experiment Station, or State Extension Turf Specialists for more specific information regarding timing of application.

**NOTE:** For optimum control, irrigation or rainfall must occur within 24 hours after application to move the active ingredient through the thatch. Do not apply more than 500 pounds of product (0.5 lb of imidacloprid active ingredient, 0.4 lb bifenthrin) per acre per year. Avoid mowing turf or lawn area until after irrigation or rainfall has occurred so that uniformity of application will not be affected.

In New York State, DO NOT apply to any grass or turf area within 100 feet of a water body (lake, pond, river, stream, wetland, or drainage ditch).

In New York State, make a single repeat application of this product if there are signs of renewed insect activity, but not sooner than two weeks after the first application.

**Annual Bluegrass Weevil (*Listronotus maculicollis*) adults:** Time applications to control adult weevils as they leave their overwintering sites and move into grass areas. This movement generally begins when Forsythia is in full bloom and concludes when flowering dogwood (*Cornus florida*) is in full bloom. Consult your State Cooperative Extension Service for more specific information regarding application timing.

**Annual Bluegrass Weevil (*Listronotus maculicollis*) larvae:** Apply at the first sign of wilting of bluegrass. For the first generation, this wilting often occurs after full bloom of flowering dogwood (*Cornus florida*).

**Armyworms, Cutworms and Sod Webworms:** If the grass area is being maintained at a mowing height of greater than 1 inch., then use higher application rates (up to 5.7 pounds per 1,000 square feet) during periods of high pest pressure.

**Billbug adults:** Make applications when adult billbugs are first observed during April and May. Degree day models have been developed to optimize application timing. Consult your State Cooperative Extension Service for information specific to your region.

**Imported Fire Ants:** Apply as a broadcast treatment up to 11.4 pounds per 1,000 square feet. For mound treatment, apply 1 cup of this product per mound and then drench the mound with 1 to 2 gallons of water. Treat mounds with sufficient force to break their apex and allow the insecticide to flow into the ant tunnels.

**Pillbugs and Sowbugs:** For heavy infestations, apply 500 pounds per acre (11.4 lb per 1,000 sq ft) of this product to non-residential turf.

**Ticks (Including ticks that may transmit Lyme disease and Rocky Mountain spotted fever):** Treat the entire area where exposure to ticks occurs. Ticks may be reintroduced from surrounding areas on host animals. Retreat to achieve and/or maintain control during periods of high pest pressure. Repeat application is necessary only if there are signs of renewed activity. Limit repeat applications to no more than one per seven days. Deer ticks (*Ixodes* spp.) have a complicated life cycle that ranges over a two year period and involves four life stages. Make applications in the late fall and/or early spring to control adult ticks that are usually located on brush or grass above the soil surface and in mid to late spring to control larvae and nymphs that reside in the soil and leaf litter. American dog ticks (*Dermacentor variabilis*) may be a considerable nuisance in suburban settings, particularly where homes are built on land that was previously field or forest. These ticks commonly congregate along paths or roadways where humans are likely to be encountered. Make applications as necessary from mid-spring to early fall to control American dog tick larvae, nymphs and adults.

**OPTIONAL SPREADER SETTINGS**

*Note: Following will be a list of application spreaders and approximate settings. This list will vary dependent on market of spreaders. (This note will not appear on final printed label.)*

**Applications Instructions**

See Spreader Settings chart below. Adjust spreader to the appropriate setting. Make sure that the spreader works properly and spreads granules uniformly. Apply to the border and then fill in the center to ensure the entire area is covered completely. To make sure that the product is evenly distributed, walk at a steady pace making parallel passes. Do not use a spreader that applies granules in narrow, concentrated or uneven bands.

**Important:** It is important to follow the directions as indicated on this quality product as over-application may cause injury to the lawn. Measure the size of the area to be treated and do not over or under apply. Spreader settings are approximate. Differences may occur due to condition of spreader, speed at which applied, and roughness of area treated. Calibrate spreader prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing uniformly. Close spreader when filling, stopping or turning.

**Note:** These spreader settings were established using standard equipment available from the spreader manufacturer at swath widths and speeds typically used within the industry. Calibrate all spreader equipment at the time of application to achieve the desired application rate.

**RESTRICTIONS**

- Do not apply more than 250 pounds of product (0.25 lb of imidacloprid, 0.2 bifenthrin) per acre per year on residential use sites (i.e. around private homes, apartment buildings, condominiums, non-agricultural outbuildings, non-commercial greenhouses, pre-schools or day care facilities).
- Avoid runoff or puddling of irrigation water following application. Avoid application of this product to areas which are waterlogged and saturated, which will not allow penetration into the root zone of the plant. Do not apply more than 500 pounds (0.5 lb of imidacloprid and 0.4 lb of bifenthrin) per acre per year.
- Replant treated areas with any crop specified on an imidacloprid and bifenthrin label, or with any crop for which a tolerance exists for the two active ingredients.
- For crops not listed on any imidacloprid and any bifenthrin label, or for crops which no tolerances for the active ingredients have been established, a 12-month plant-back interval must be observed.
- Do not apply by air.
- Not for use in nurseries or commercial greenhouses.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**PESTICIDE STORAGE:** This product should be stored in its original container in a cool, dry locked place out of the reach of children and out of direct sunlight. Do not use or store near heat or open flame.

#### **[Nonrefillable containers larger than 5 Gallons:]**

**Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Plastic containers are also disposable by incineration. Do not burn unless permitted by state and local ordinance if burned stay out of smoke.

### [Nonrefillable bags]

**CONTAINER DISPOSAL:** Nonrefillable container. Do not reuse or refill this container. Completely empty bag into application equipment, then offer for recycling if available, or dispose of empty bag in a sanitary landfill or by incineration. Do not burn unless permitted by state and local ordinance. If burned, stay out of smoke.

### [Refillable drum with a Nonrefillable liner]

**CONTAINER HANDLING:** Refill this container with pesticide only. Do not use this container for any other purpose.
