CABBAGE, CAULIFLOWER, BROCCOLI, BRUSSELS SPROUTS, LETTUCE: Aphids, Leaf Miner, Downy Mildew— 20 to 25 lbs. per acre. Do not apply to Cabbage within 10 days of harvest and to Cauliflower, Broccoli, Brussels Sprouts and Head Lettuce within 7 days of harvest. Do not apply to Leaf Lettuce within 21 days of harvest.

CELERY: Aphids, Worms, Thrips, Red Spider Mites, Early 2 and Late Blight-Use 20 lbs. per acre. Do not apply within 21 dc s of harvest. By Airplane—50 lbs. per acre. Do not apply within 30 days of harvest.

POTATOES and TOMATOES: Aphids, Leafhoppers, Thrips, Early and Late Blight—Use 22 lbs. per acre. Do not apply to tomates within 10 days of harvest and to potatoes within 5 days of harvest.

SQUASH: Aphids, Pickle and Melon Worms, Red Spider Mites, Blight, Downy and Powdery Mildew-17 lbs. per acre. Do not apply within 15 days of harvest.

STRAWBERRIES: Red Spider, Aphids, White Fly, Cyclamen Mite, Thrips, Lygus Bugs, Potato Leafhoppers, Downy and Powdery Mildew-20 lbs. per acre. Repeat against Red Spider in 7 to 10 days. Apply when insects or diseases appear. Do not apply within 14 days of harvest.
