

DIRECTIONS

Apply this product as a fine, mist-type space spray with a convenient atomizer-type sprayer. Coarse droplets must be avoided. No dilution is necessary.

BUILDINGS: (such as Homes, Restaurants, Food Processing Plants): Flies, Mosquitoes, Gnats: Close all doors and windows where possible, then spray all parts of the room thoroughly. Use approximately 2 ounces of ORTHO Fly Spray "101" to each 1000 cubic feet of space. Direct the spray toward the ceiling and upper areas of the building, concentrating on beams, rafters and other areas where flies congregate. Doors and windows may be opened after 10 to 15 minutes. Treat daily or as required. Keep away from food surfaces or containers. Avoid food contamination. Use the product as a space spray in food processing plants only when plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered or thoroughly cleaned before using.
