It gives excellent control of STINKING SMUT OR COMMON BUNT of wheat (seed and soil borne) and increases the stand by reduction of damping-off, seed rot, seedling blight and decay.

DIRECTIONS

DRILL BOX TREATMENT—2 ounces per bushel seed (3 $\frac{1}{3}$ ozs. per 100 lbs. seed). Mix thoroughly with seed in drill box before planting.

DUST TREATMENT—Apply 2 ounces per bushel seed (3 $\frac{1}{3}$ ozs. per 100 lbs. seed). Mix thoroughly with seed in dusting machine, barrel or other container.

CAUTION: Avoid inhalation. Avoid contact with skin. Wash thoroughly after using. Avoid contamination of feed and foodstuffs. Do not use treated seeds for human consumption. Treated seeds should not be used for feed, food or oil purposes. Do not feed treated seed to livestock. Treated seed should be labeled as follows: **"TREATED SEED. DO NOT USE FOR FOOD, FEED OR OIL."** When container is empty, immediately wash thoroughly and destroy. Never re-use.
