Ortho Systemic Rose and Flower Care

Dear: Mr. Levey:

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below:

- 1. Revise the "Precautionary Statements" section of your label to read "May be fatal if swallowed or absorbed through skin. Causes moderate eye irritation. Do not get in eyes, on skin, or on clothing. Wear long-sleeved shirt and long pants, socks, waterproof footwear, and gloves. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco. Remove contaminated clothing and wash clothing before reuse. Cotton gloves should be laundered or discarded and rubber gloves washed with soap and water after each day's use.
- 2. Revise your "First Aid" statements to read:

"IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or a doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center for treatment advice.

In our letter of January 14, 2001, we acknowledged that your product is currently dormant (as per your letter of September 19, 2000) and agreed that prior to remarketing this product, you would have to comply with the requirements stated in PR Notice 9-2. Does this label amendment indicate that you intend to begin marketing this product? If so, then you must comply with PR Notice 96-2.


