PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS & DOMESTIC ANIMALS
CAUTION: May be harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of areas being treated. Avoid contact with skin, eyes, or clothing. Do not allow children to contact treated surface until surfaces are completely dry. Avoid contamination of food, utensils, and food preparation areas. Do not use in commercial food preparation areas or in edible products areas of food processing plants. Remove pets and cover squares in areas to be treated. ORTHO Ant, Roach & Spider Spray is a highly effective formulation which provides rapid kill of such crawling insects as listed below, including those resistant to certain chlorinated hydrocarbon and phosphate insecticides.

In addition to rapid initial kill, ORTHO Ant, Roach & Spider Spray stays on treated surfaces and provides residual insect killing power after the spray deposit has dried.

HOW TO USE: Spray infested surfaces until wet, moving the spray stream rapidly to prevent excessive wetting of surfaces, and waste of material. Point spray away from people, plants and pets.

RESTRICTIONS: Do not apply to rugs, carpets, asphalt tiles, diapers, wallpaper or similar materials that may be stained. Avoid excessive wetting of plastic and rubber surfaces such as tires and floor coverings.

DIRECTIONS

ANTS, COCKROACHES, CRICKETS, SPIDER, SPIDERS: INDOORS—Spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around wall-to-wall carpeting. Spray and treat all places where ants enter premises. Repeat as needed. Residual activity against roaches lasts from 4 to 8 weeks. For flushing crawling pests out of hiding, use ORTHO HI-POWER™ Indoor Insect Fogger after applying this product.

BROWN DOG TICKS: Spray sleeping areas of pets, around bedding, window and door frames, wall cracks and local areas of fleas. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

ANTS, CRICKETS, EARTHWORMS, SPIDER, SPIDERS, AND BROWN DOG TICKS—OUTDOORS: Spray in infested areas thoroughly, including outside surfaces of screens, doors, windows, frames, fence posts, patios, or other places where insects may enter. For ants, spray hills and cutways. Repeat as necessary. Do not spray vegetation.

STORAGE AND DISPOSAL

STORAGE: Store in a secure, preferably locked, storage area away from heat or open flame.

DISPOSAL: PRODUCT—Unused product may be disposed of by securely wrapping original container in several layers of newspaper and deposit in trash. CONTAINER—Replace cap and discard container in trash. Do not incinerate.
