
DIRECTIONS

SHAKE BEFORE USE. Point valve opening away from face and angled slightly downward. For best results, use when air is calm or breeze is slight.

FOR FLYING INSECTS (Flies, Mosquitoes, Gnats, Wasps): Spray with the breeze and allow fog to drift over areas to be protected. When treating grass or bushes, stand at least 4 to 6 feet away and drift spray on to areas to be protected. Repeat as necessary.

FOR CRAWLING INSECTS: Ants, Crickets, Centipedes — Spray infested surface of patio or picnic area, hitting as many insects as possible. Spray legs of tables and chairs to repel ants. Spray ant hills and trails thoroughly for best control.
