ORTHO Mole Cricket Bait is a ready-to-use product that controls Mole Crickets, Field Crickets and Roaches. It gives rapid kill of these insects including Roaches resistant to certain chlorinated hydrocarbon and phosphate insecticides.

DIRECTIONS

Mole Cricket Control (Florida Only): Mole Crickets are soil inhabiting insects that damage lawns by feeding on grass roots and by forming mole like tunnels that loosen the soil causing the grass to dry out. The adults grow to 1 1/2 inches long, are brownish and have flattened front legs well adapted for tunneling. Feeding and tunneling occurs primarily at night. The meandering tunnels are easily seen in short or newly planted lawns. Heavily infested lawns gradually turn brown and die.

How To Apply: For best results the lawn should be mowed and watered thoroughly before application. Apply ORTHO Mole Cricket Bait at the rate of 1/2 lb. to cover 1,000 sq. ft. For fast easy application use an ORTHO WHIRLYBIRD Spreader. Using setting No. 1, apply one WHIRLYBIRD full (1 1/2 lbs.) to 3,000 sq. ft. Apply at dusk when overnight rains are not expected. If rain should occur within 36 hours after treatment, the lawn should be retreated.

Roach and Field Cricket Control: For use in and around homes, apartment buildings, stores and restaurants—Apply bait lightly to floors under sinks and refrigerators and in other areas such as cracks and crevices where pests may hide but which are inaccessible to children. Use approximately 4 oz. of bait per 1,000 sq. ft. of treated area. Scatter lightly so that bait is barely visible. Repeat as necessary. Keep out of reach of children.

Important: Do not apply to animals. Do not treat portions of buildings where pets can feed on bait. Do not put bait in piles. Do not broadcast on floors inside that are likely to be contacted by children or pets. Do not use on food crops.

STORAGE AND DISPOSAL

STORAGE: Keep pesticide in original container. Do not put into food or drink containers. Avoid contamination of feed and foodstuffs. Store in a cool, dry place, preferably in a locked storage area.

DISPOSAL: PRODUCT—Partially filled bag may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. **CONTAINER—**Do not reuse bag. Discard bag in trash.
