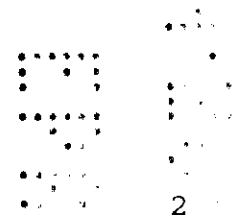
<b>Product Facts</b>	
Kills Insects	Flies, gnats, mosquitoes, moths, ants, centipedes, crickets, Sowbugs, spiders, hornets and wasps
Where to Use	In backyards, around patios, garbage cans and other areas. Kills insects resting on treated areas.

<b>How to Use</b>	
1. Shake Well. 2. Point nozzle away from face. 3. Spray while moving away from treated area. 4. Let spray dissipate before entering area. Repeat as needed. Do not smoke when using this product. Spray away from people or animals. Cover food before spraying. Do not spray on food crops.	
Flies, Gnats, Mosquitoes, Moths	Hold container 4 feet away from plants, shrubs and grass. Direct spray to fill air around these plants without heavily wetting foliage. Allow spray to disperse for several minutes before entering the treated area.
Wasps, Hornets	Spray directly on wasps and hornets. Thoroughly wet nesting area in evening when insects are less active.
Ants, Centipedes, Crickets, Sowbugs, Spiders	Treat areas around garbage cans. Thoroughly spray ant hills.
Brown Recluse Spiders, Black Widow Spiders	Spray directly on pests in 2 second bursts, from 6 feet away.

**STORAGE AND DISPOSAL**

**STORAGE:** Store in a secure, preferably locked storage area away from heat or open flame.

**DISPOSAL:** Do not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
