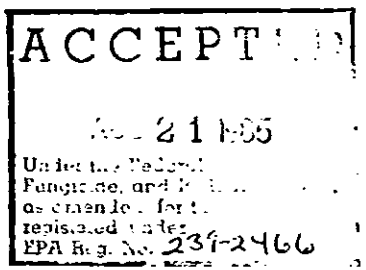


**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC ANIMALS**

ORTHO Systemic Spot Weed & Grass Killer is formulated for "spot" application to individual weeds. This spot weeder produces a "foamy" white lather for direct weed contact which avoids drift and marks weeds as treated. The weed killer moves systemically through all parts of the plant. Visible effects usually occur within 1 week on most weeds with complete kill in 2 to 4 weeks.

DIRECTIONS

Shake can just before using and occasionally during use. Invert can, hold at arms length and point can at weed as you press button. Do not press button when can is in upright position. Stand close to weed (1 to 2 feet) with can aimed at weed and away from face. Push down briefly on button. Spray to cover center of weed. Do not overspray. The spray foaming action will make it easy for you to see coverage. One application will kill most weeds listed. If certain tough weeds, i.e., nutgrass, Bermudagrass, Canada thistle or field bindweed (wild morningglory) are not completely controlled within 4 weeks, repeat application. This product is a non-selective weed killer and will kill all vegetation contacted. Treated areas in lawns can be reseeded 7 days after application. Do not apply when rainfall is expected within 24 hours of application as weed control will be reduced.

IMPORTANT: This product is a non-selective weed killer and will kill all vegetation contacted. Be careful when treating weeds not to spray surrounding desirable grasses or they will also be killed. Avoid spraying or spattering nearby desirable plants. Do not apply when rainfall is expected within 24 hours of application as weed control will be reduced. If spray drift accidentally contacts desirable foliage, wash off immediately with water.

STORAGE AND DISPOSAL

STORAGE: Store in a secure, preferably locked storage area away from heat or open flame.

DISPOSAL: PRODUCT—Unused product may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. **CONTAINER**—Replace cap and discard in trash. Do not incinerate or puncture.
