2. To prevent the growth of Sedge, Crabgrass, Spotted Spurge and Paspalums and fertilize grass, apply in January, February or March, before these weeds germinate. This product will not control these weeds if they are already present in the lawn at the time of application.

In newly sprigged St. Augustine grass lawns, apply soon after planting to reduce competition from weeds.

HOW TO APPLY

The contents of this bag will cover 3,000 sq. ft. (100' x 30') when applied according to directions. If soil is dry, water lawn thoroughly the day before treatment. Treat entire lawn evenly. Do not exceed the recommended rate. Immediately after application, water lawn to wash material off the grass blades and into the soil.
