ORTHO Dormant Insect & Disease Control kills overwintering insects on contact and halps prevent foliage diseases from occurring during the growing season by killing disease causing fungus spores that over-winter on buds, twigs and back and by providing a protective covering of the buds before they open in the spring. Since many of the disease organisms covered on this label also over-winter on old leaves, they should be raked up in the fall and discarded.

Directions: Shake well before using. Use a forceful spray, wetting pests and all perts of plants thoroughly. Make new dilution for each use. May be applied through an ORTHO SPRAY-ETTE hose and aprayer, tank type or power sprayer. Keep agitating during apraying.

Rate to Use-Mix 5-1/2 ft. oz. (11 tablespoonfuls) per gallon of water or one guart in 6 gallons of water. To apply with an ORTHO SPRAY-ETTE add amount of undiffuted product required to the sprayer jar. Do not add water to jar. Do not use the ORTHO Lawn Sprayer. Do not spray when the temperature is over 80°F, or under 45°F. Keep out of drift while applying sprays.

Dormant Spraying for Insects: Scales, Red Spider Mites, Mealybugs and Overwintering Insect Eggs on Dormant Deciduous (no leaves on plants during the winter) Fruit Trees (Apples, Plums, Pears, Peaches, Cherries); Caneberries; Roses, Shrubs and other Woody Plants; and Shade Trees.

Thoroughly spray all bare limbs, branches and trunks in winter before buds begin to swell. Avoid application to evergreens as lotiar discoloration or other injury may occur.

DORMANT SPRAYING FOR DISEASE

PEACHES: Peach Leaf Curi, Peach Blight-Timing is very important. Late Fall-Spray in October or November after leaf drog but before heavy rains occur. Mid-Winter-Apply a full coverage spray in January or February before buds begin to swell. Nata: If buds have begun to swell or open, it is too late to obtain satisfactory control of Peach Leaf Curl Disease as infaction has already occurred. For best results we use a combination of Late Fall and Mid-Winter applications.

ROSES: Black Spot, Powdery Mildew, Rust-Prune and destroy all old leaves. Spray in the spring before buds begin to swell.

PEARS: Blister Mita-Apply in the fall before the leaves start to turn color and again in the spring just as the buds begin to swell.

BLACKBERRIES, RASPBERRIES: Lasi Spot, Cana Blight, Powdery Mildaw-Pruna out old cames and destroy before fall rains. Apply in late fall and again in the spring as the buds bagin to swall.

Note: Avoid spraying on painted surface as staining may occur. Keep bottle lightly closed. Do not use on follage during growing season. Do not use on apricots as they are injured by sulfur sprays.
