Directions: Wet the animal thoroughly sprinkling on a small amount of shampoo. Create lather at the head, working well around the ears. Then lather over animal's entire body, working backward. Be sure lather is rubbed thoroughly into folds of skin, between the toes, etc. Allow lather to remain approximately five minutes, then rinse. For stubborn cases repeat as above.

CAUTION: Eye irritant. Avoid contact with eyes. Harmful if swallowed.

FIRST AID: In the event of eye contact, flush eyes with large amounts of clear water for at least 15 minutes. If irritation persists, seek medical attention. If swallowed, do not induce vomiting.
