The application referred to above, submitted under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable under FIFRA sec 3 (c)(5). In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

#### Foliar uses on:

Artichoke; asparagus; barley; head and stem brassica (Subgroup 5A); leafy brassica greens (Subgroup 5B); citrus (Crop Group 10); corn; cotton; cucurbits (Crop Group 9); fruiting vegetables; herbs (Subgroup 19A); dill grown for seed; small fruit vine climbing subgroup (except fuzzy kiwifruit), Subgroup 13-07F; grasses grown for seed; hops; leafy green vegetables (Subgroup 4A); leafy petiole vegetables (Subgroup 4B); oats; peanuts; pistachios; pome fruits (Crop Group 11); potatoes and tuberous and corm vegetables (crop Subgroup 1C); rice; root vegetables (Subgroup1B); soybeans; low growing berry, subgroup 13-07G (except cranberry); stone fruits (Crop Group 12); sugar beets; tree nuts (Crop Group 14); mango; papaya; sapodilla; black sapote; mamey sapote and star apple; wheat; turf sites including golf courses; institutional, commercial and residential lawns; sod farms; sports fields; parks; municipal grounds and cemeteries; ornamentals grown in interiorscapes; field nursery plantings; forest nurseries; residential and commercial landscapes; greenhouses; lath and shadehouses; containers and other enclosed structures.

Canola, corn (field corn, field corn grown for seed, and popcorn), cotton, cucurbit vegetables, fruiting vegetables, legume vegetables (succulent and dried), mustard seed, peanut, potatoes (seed-piece), rapeseed, rice, sorghum, soybean, sugar beets, wheat, conifer, ornamental flowers and turf.

#### STORAGE AND DISPOSAL

Do not contaminate food or feed by storage or disposal.

#### PESTICIDE STORAGE

Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

#### **CONTAINER HANDLING**

#### [Dilutable Manufacturing Use Products in Non-Refillable Plastic Containers]

Rigid, Non-refillable containers (equal to or less than 5 gallons)

Non-refillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into manufacturing equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into manufacturing equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into manufacturing equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over manufacturing equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Once container is rinsed, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration.

Rigid Non-refillable containers that are too large to shake (i.e., with capacities greater than 5 gallons or 50 lbs)

Non-refillable container. Do not reuse or refill this container. After emptying product from container, either return container to Bayer CropScience per instructions from Bayer CropScience Customer Service Center (1-800-527-4781), or rinse and either recycle or dispose of the container as follows:

Bottom Discharge IBC (e.g. – Schuetz Caged IBC or Snyder Square Stackable)

Pressure rinsing the container before final disposal is the responsibility of the person disposing of the container. To pressure rinse the container before final disposal, empty the remaining contents from the IBC into manufacturing equipment. Raise the bottom of the IBC by 1.5 inches on the side which is opposite of the bottom discharge valve to promote more complete product removal. Completely remove the top lid of the IBC. Use water pressurized to at least 40 PSI to rinse all interior portions. Continuously pump or drain rinsate into manufacturing equipment. Continue pressure rinsing for 2 minutes or until rinsate becomes clear. Replace the lid and close bottom valve.

#### Top Discharge IBC, Drums, Kegs (e.g.- Snyder 120 Next Gen, Bonar B120, Drums, and Kegs)

Triple rinsing the container before final disposal is the responsibility of the person disposing of the container. To triple rinse the container before final disposal, empty the remaining contents from this container into manufacturing equipment. Fill the container at least 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Rinse all interior surfaces. Pour or pump rinsate into manufacturing equipment. Repeat this procedure two more times.

Once container is rinsed, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration.

#### [Dilutable Manufacturing Use Products in Non-Refillable Metal Containers]

Nonrefillable container. Do not reuse or refill this container. After emptying product from container, either return container to Bayer CropScience per instructions from Bayer CropScience Customer Service Center (1-800-527-4781), or rinse and either recycle or dispose of the container as follows:

#### Any dilutable pesticides in containers too large to shake (larger than 5 gallons or 50 pounds)

Triple Rinse as follows: Empty remaining contents into manufacturing equipment. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into manufacturing equipment or store rinsate for later use or disposal. Repeat this procedure two more times.

Once container is rinsed, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration.

#### [Non-Dilutable Manufacturing Use Products in Non-Refillable Containers]

#### Manufacturing Use Products in Non-Refillable Fiber Drums with Liners

Non-refillable container. Do not reuse or refill this container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing equipment, then offer for recycling if available or dispose of in a sanitary landfill or by incineration. If drum is contaminated and cannot be reused, dispose of it in the manner required for its liner.

#### Manufacturing Use Products in Non-rigid, Non-Refillable Containers
