Do not treat puppies or kittens less than four weeks of age.

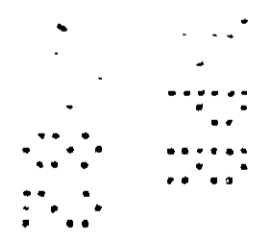
