## DIRECTIONS FOR USE

ORNAMENTAL TURF, HOME LAWNS: Crabgrass - Use 13 lbs. per 1,000 sq. ft. of turf. Apply in sufficient water to obtain uniform coverage of treated area. Application should be made in the late winter or spring prior to the emergence of the crabgrass seedlings. The treated area should be well watered immediately after application. Keep children and animals off treated area until this material has been thoroughly watered into the soil and the grass has completely dried. Apply to well-established lawns only. This material may injury certain varieties of bentgrass, blue grass and fescues. Injury will usually be in the form of a thinning of the grass stand.

Multiple applications during the same year, or single application of the above dosage for two or more consecutive years is not recommended. Treatment should be limited to a single application of the above dosage during the first year treatment is undertaken and in succeeding years, treatments of one—thi. It is initial dosage may be applied should the problem persist. This reduction of the dosage in subsequent treatments is designed to prevent excessive thinning of turf. If additional crabgrass control is desired within one year from the date of a calcium arsenate application, another recommended control measure should be used.

If reseeding of the treated area is desired, such reseeding should not be attempted within 6 months of the time of treatment.

POULTRY HOUSES: For control of the larval (maggot) stage of the house fly and soldier fly in litter droppings under caged chickens and turkeys on wire floors. Use 2.4 lbs. in 4 gallons of water. Agitate well and apply as a coarse spray to 1000 sq. ft. of droppings or manure piles on a preventative schedule. Repeat as manure is added. Use only on droppings where poultry cannot come in contact with the material. Do not spray directly on poultry or feed and water. Repeat on 5-7 day intervals. CAUTION: Do not apply manure treated with this product to food crops.

TOMATOES: Tomato Fruit Worm, Hornworm, Flea Beetles - Use at the rate of 3 lbs. per acre in sufficient water to provide uniform coverage. Repeat applications as required. Remove residues remaining at harvest by washing, wiping, brushing or other effective means.


