Asparagus Asparagus Beetle - Use 30 pounds per acre.

Beans Mexican Bean Beetle - Use 30 to 40 pounds per acre. Thorough coverage of under surfaces of leaves is essential for effective control.

Beets Flea Beetle - Use 20 to 30 pounds per acre.

Broccoli, Brussels Sprouts, Cabbage, Caulillower Imported Cabbageworm, Cabbage Looper, Flea Beetle - Use 25 pounds per acre.

Cucumbers. Melons, Squash Cucumber Beetles. Squash Bug Nymphs, Aphids - Use 25 pounds per acre. Squash Vine Borer - Use 30 pounds per acre. Apply thoroughly around base of plants at weekly intervals.
