

Directions for use

Blueberries

On blueberries for the control of certain leaf defoliating diseases such as Rust, Powdery Mildew and Brown Leaf Spot, and for Twig Blight, apply at the rate of 15 to 50 lbs. per acre depending on the size of the plants, making applications just before bloom, and when most of the petals have dropped, and ten to fourteen days later. Do not apply within 40 days of harvest.

Apples

This material may be used as a dust on apples for the control of Scab, Bitter Rot, Rust, Brooks Spot and Blotch. On Golden Delicious, Grimes Golden, Jonathan and other varieties which are especially subject to russeting the use of this material should be avoided, or it should be used with caution in applications ahead of, or during and shortly after, the blossom period.

On varieties not subject to russeting apply in the prebloom and petal-fall stages. Repeat at 7 to 10 day intervals during the season.

The usual rate of application is $\frac{1}{2}$ to 2 lbs. per tree, depending upon the size.

Do not apply on apples within 7 days of harvest.
