DIRECTIONS FOR USE

Use as a scray at the mate of 10 to 12 pounds Niagara Powle, ed blues one with 10 to 12 pounds Niagara Sprry Lime per 100 gallons of water. Start the water into the spray tank and with the agitator running add the required amount of Niagara Powdered Bluestone. When the tank is 3/4 full add the required amount of Niagara Spray Lime. Keep the agitator running.

ON **PEACHES:** For the control of peach blight and leaf curl apply as a fall spray and in the spring before bud swell. For the control of brown rot and peach blight apply as a pre-blossom and petal fall

spray. ON ALMONDS: For the control of shot hale fungus apply as a fall spray and in the spring at bud swell; for the control of brown rot and shot hole fungus apply as a pre-blossom and petai fall spray. ON APRICOTS. PRUNES AND PLUMS: For the control of shot hole fungus apply as a fall spray and in the spring at bud swell; for the control of brown rot use the same recommendations given above for peaches.

ON CITRUS: For control of Brown Rot, use 2 pounds Miagara Powdered Bluestone with 2 pounds Miagara Spray Lime per 100 gallons of water. Apply during the fall or winter periods when brown Rot may be a problem. Mry be combined with Zinc Sulfate and additional lime to make a whitewash spray.


