Make thorough, full coverage application when insects or disease first appear and repeat as necessary. May be applied by air or ground. Observe days interval between application and harvest indicated by number in () following the crop.

APPLES (3): Aphids, Mealybug, Codling Moth, Fruittree Leafroller and Powdery Mildew — Use 50 to 80 pounds per acre. Sulphur and Malathion may injure certain varieties of apples, check tolerance prior to use.

BLACKBERRIES (1), BOYSENBERRIES (1), DEWBERRIES (1), LOGANBERRIES (1), RASP-BERRIES (1): Powdery Mildew, Aphids and Rose Scale — Use 40 to 60 pounds per acre.

<u>GRAPES</u> (3): Leafhopper, Drosophila and Powdery Mildew — Use 30 to 50 pounds per acre. Ground application preferred. Emulsion may cause injury to foliage on some varieties.

PECANS (0): Pecan Nut Casebearer — Use 100 pounds per acre. Apply when first brood larvae begin to enter nuts and repeat after 7 days as necessary. Pecan Bud Moth — Apply 10 pounds per acre by airplane. Apply 4 to 5 times, 2 to 3 weeks apart when insects appear.

PEACHES (7), NECTARINES (7): Peach Silver Mite, Aphids, Oriental Fruit Moth, Brown Rot and Powdery Mildew — Use 50 to 80 pounds per acre.

<u>PEARS</u> (1): Pear Psylla, Mealybug, Codling Moth, Fruittree Leufroller and Powdery Mildew — Use 50 to 80 pounds par acre.

PLUMS (3), PRUNES (3): Aphids, Brown Rot and Prune Rust — Use 50 to 80 pounds per acre.

<u>STRAWBERRIES</u> (3): Aphids, Lygus Bugs, Spittlebug, Field Crickets, Thrips, Potato Leafhopper, Whitefly, Strawberry Leafroller and Powdery Mildew — Use 50 pounds per acre.

BEANS (1): Mexican Bean Beetle, Leafhoppers, Aphids, Cucumber Beetle and Powdery Mildew — Use 30 to 40 pounds par acre. Sulphur may injure certain varieties, check sulphur tolerance prior to use.

BRUSSELS SPROUTS (7), COLLARDS (7): Aphids and Imported Cabbageworm — Use 35 to 60 pounds per acre.

CAULIFLOWER (7): Aphids — Use 50 to 60 pounds per acre. Imported Cabbageworm — Use 30 pounds per acre.




