DIRECTIONS FOR USE

APPLES

This material is for use as a dust on apples in the cover applications where scab is still a problem and where parathion is desired for the control of mites, aphids, codling moth and red-banded leaf roller.

Applications should be made at the rate of ½ to 2 pounds per tree, depending upon the size.

Do not apply this material within 14 days of harvest. For disease control in this period the use of Niagara Niacide M Dust is recommended.

Parathion may cause injury to fruit and foliage of McIntosh and related varieties.

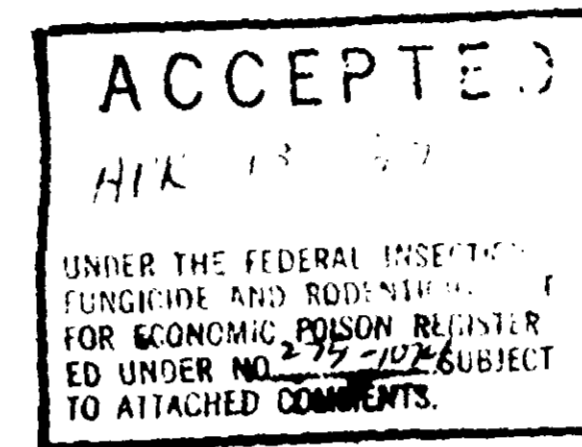
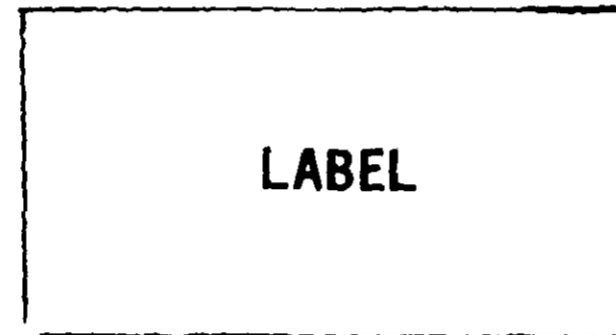
