DIRECTIONS FOR USE

APPLES: Apple Scab, Apple Aphid, Apple Maggot, Codling Moth, Red Banded Leaf Roller - Use at the rate of 40 pounds of dust per acre. Apply during normal cover applications, beginning 15 days after petal fall. Dust trees thoroughly. For Red Banded Leaf Roller control, it is important to dust lower surface of leaves. When Apple Maggot becomes active, apply at 10 day intervals for optimum control. Do not apply within 1 day of harvest.

Application of Sevin within 30 days after full bloom may also provide fruit thinning. To avoid this, delay use until at least 30 days after bloom. May cause foliar injury if used before second cover on York and McIntosh apples.

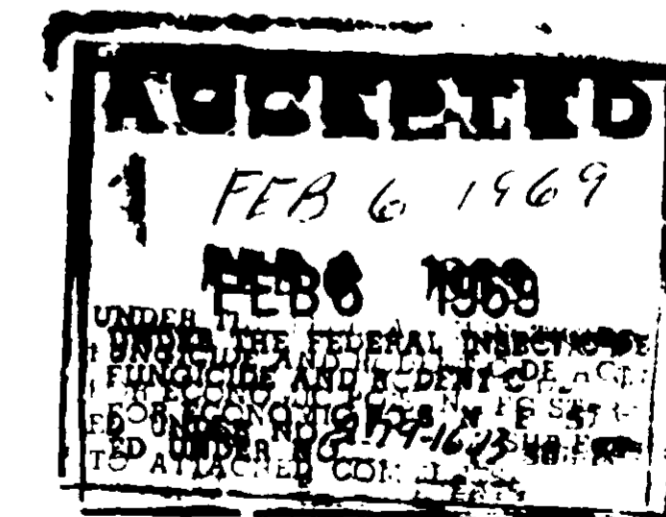

USAGE CAUTIONS

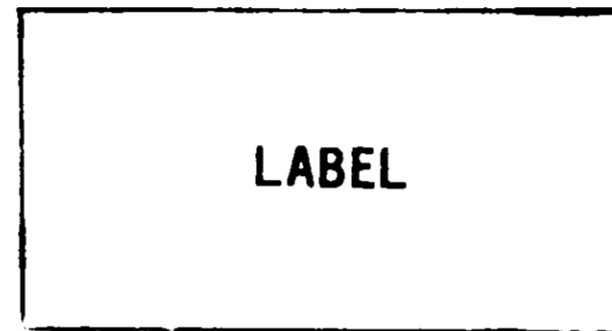
