Sabadilla 2.25 Wettable is an especially formulated wettable powder for the control of citrus thrips on citrus trees.

DIRECTIONS FOR USE

CITRUS: To control citrus thrips apply 3-4 pounds per 100 gallons of water plus 8 pounds of sugar when thrips first appear at petal fall time. Apply 100 gallons per acre using a spray duster or other adequate equipment to give thorough coverage. When unable to get into orchard with ground equipment, apply 3-4 pounds per acre plus 8 pounds sugar in 15-20 gallons of water by airplane. Do not apply when trees are in bloom. May be applied on day of harvest. If adult population is high, add 4 lbs. Parathion 25% wettable powder per acre to the above Sabadilla 2.25 Wettable recommendation. Do not use within 14 days of harvest when Parathion is added. Do not apply when trees are in bloom.
