DIRECTIONS FOR USE OBSERVE USE CAUTIONS

IN AND AROUND BUILDINGS: Ants, Earwigs, Roaches, Sowbugs — Use 10½ tablespoonfuls per 1 gallon of water. (5½ tablespoonfuls for outdoor use where valuable plants might be contacted). Spray around building foundation, along fences, around refuse or trash, infested cracks and other hiding places of insects. For ants, treat also openings around pipes, heat ducts, electrical outlets and baseboards where ants enter room from wall space and partitions. Repeat as needed. Do not use in dairy barns or poultry houses. Do not use in edible product areas of food processing plants.

Spiders, Centipedes — Use 10½ tablespoonfuls per 1 gallon of water. Spray around infested baseboards, pipes and all infested areas in basement. Repeat as needed.

Crickets, Silverfish — Use 10½ tablespoonfuls per 1 gallon of water. Spray around baseboards, closet floors, storage places, behind shelving and bookcases. Repeat as needed.

Termites — Use 1 to 2 gallons per 100 gallons of water, or 1 to 2 pints per 12½ gallons of water. For the protection of wooden structures against termites, dig a trench next to the foundation 12 inches wide and 30 inches deep, but not below the top of the footing, all the way around the building. Apply spray at the rate of 1 gallon per linear foot of trench using low pressure spraying equipment. Also treat soil as trench is being refilled. Annual termite inspections are necessary when rates less than 2 gals. per 100 gals. or 2 pts. per 12½ gals. of water are applied.

Carpet Beetles — Use 10½ tablespoonfuls per 1 gallon of water. Thoroughly spray infested areas of carpet, localized areas of floors, baseboards, cracks and under carpet. Repeat as needed.

CAUTION: For indoor use first check by applying on small areas of articles, particularly fabrics, for likelihood of staining. Apply Chlordane, only as directed, for spot treatments within the home.

Forage treated or contaminated with this material should not be fed to dairy animals or livestock being finished for slaughter.

LAWNS: Sod Webworm, Lawn Moths — Use ¼ pint in 5 gallons of water per 1200 sq. ft. Sprinkle lawn before spraying. Do not sprinkle again for 48 hours.

Ants, Ticks, Chiggers, Armyworms, Crickets — Use ¼ pint in 5 gallons of water per 1650 sq. ft. After spray is applied, do not sprinkle lawn for 48 hours.

Chinch Bugs, False Chinch Bugs, Cutworms — Use ¼ pint in 5 gallons of water for 1650 sq. ft. After spray is applied, sprinkle lawn thoroughly.

Keep children and domestic pets off lawns and turf until they have been thoroughly watered and completely dry.
