# <sup>9</sup> Methyl Parathion 2 Sevin 7.5 DUST

INSECTICIDE - MITICIDE

#### **DIRECTIONS FOR USE**

NOT FOR USE OR STORAGE IN OR AROUND THE HOME.

CROP: Cotton

TO CONTRC': Aphids, boll weevil, boll-worm, cotton leaf perforator, fleahoppers, leafworm, lygus bugs and other mirids, pink bollworm, spider mites, thrips, fall army-worm, Methyl Parathion will control the Bimaculatus (two-spotted) and Desertorum species of spider mites, but will not control the Tumidus species.

#### **REMARKS:**

Use 20 to 30 pounds of dust per acre. Apply when insects first threaten damage to crop, and repeat at 5 to 7 day intervals as required to maintain control.

Do not handpick or harvest within 7 days of last application. Workers entering fields within 24 hours after application should wear protective clothing.

#### FIRST AID

If On Skin or Clothing: Remove contaminated clothing and shoes immediately. Bathe with soap and water. Call a Physician Immediately.

NOTE TO PHYSICIANS: Methyl Parathion is a cholinesterase inhibitor. Patient should be kept under observation for 48 hours. Atropine is antidotal. Give 4 mg. intramuscularly or intravenously. Repeat every 15 minutes until patient is fully atropinized. If cyanotic give artificial respiration. DANGER: POISONOUS If Swallowed, Inhaled or Absorbed Through Skin! Rapidly Absorbed Through Skin! Do not get in eyes, on skin or on clothing. Wear natural rubber gloves, protective clothing and goggles. In case of contact wash immediately with soap and water. Wear a mask or respirator of a type passed by the U.S. Bureau of Mines for methyl parathion protection. Keep all unprotected persons out of operating areas or vicinity where there may be danger of drift. Vacated areas should not be re-entered until drifting insecticide and volatile residues have this pated. Do not contaminate feed and foodstuffs. Wash hands, arms and face thoroughly with soap and water before eating or smoking. Wash all contaminated clothing with soa, and hot water before reuse


