\*For mound treatment for temporary control of Imported Fire Ants tear down mound with a hoe or rake. Apply 2 to 4 cupfuls per mound and to the ground within 3 feet on all sides.

On established lawn and turf areas, wash down into the turf and soil. On non-seeded areas apply and cultivate into the soil to a depth of 3 to 6 inches. This material may be applied with a regular granular applicator Cyclone seeder or broadcasted by hand. Wear protective gloves when broadcasting by hand.

Do not treat soil when it is wet. Apply before rain or sprinkling. Do not allow persons or pets on treated areas until the material has been worked or washed into soil and is completely dry. Treated areas should not be grazed by dairy animals or animals being finished for slaughter.
