DIRECTIONS FOR USE

COTTON: To control seedling diseases related to *Fusarium*, *Pythium*, *Rhizoctonia* and *Thielaviopsis* species of soil fungi, use 1 to 2 quarts in 10 to 20 gallons of water per 13,000 linear feet of row or per acre on 40-inch row spacings. Apply in the seed furrow at planting time. Do not allow food animals to eat foliage or vines in or from treated fields.

Do not plant any root crop not registered for PCNB in rotation on PCNB treated soil.

MELONS: FOR USE IN CALIFORNIA ONLY: To control damping-off and seed rot caused by *Pythium* and *Rhizoctonia* species of soil fungi. Use 1/2 to 1 quart in 10 gallons of water per 6,500 linear feet of row or per acre on 80-inch row spacings. Apply in the furrow and covering soil at planting time.

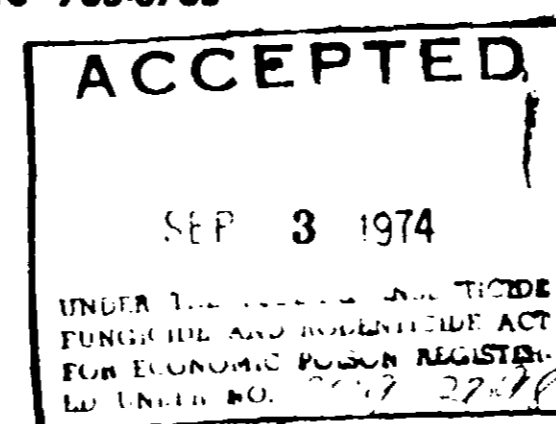
