Directions for use

Not for use or storage near or around the home.

Tobacco: For use on tobacco plants. Apply to plants in the field. Repeat applications as needed. Do not apply to plants less than 10 days old. Do not apply to plants during flowering and pollination periods. Do not apply to plants during cutting. Do not apply to plants during contact with the skin or other parts of the body when cutting the crop. Gloves should be worn in transferring the plants or harvesting leaf if an application has been made within 30 days. Avoid the use of this material during flowering and pollination periods.

Environmental and Usage Cautions

This product is toxic to fish, birds and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, ponds and streams. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
