

CROP: Pear uts

INSECTS: Fleahopper, Thrips, Velvetbean Caterpillar, Corn Earworm, Fall Armyworms, Green Cloverworm, Leafworm, Potato Leafhopper, Climbing Cutworm

DISEASES: Cercospora Leaf Spot

Apply undiluted as a dust to control thrips, velvetbean caterpillar, corn earworm, Fall armyworm, green cloverworm, and potato leafhoppers. Use at the rate of 20 to 25 pounds per acre when disease or insects first appear. To control fleanoppers, leafworm and climbing cutworms use 27 pounds per acre. If a heavy rain occurs within twenty-four hours of the first application repeat the application within three days. Repeat applications at tentotwelve day intervals. Application should be made with a dusting machine capable of depositing a thin uniform coating of dust on all above ground plant surfaces.

This material may be applied up to the day of Farvest.

Do not feed treated forage to dairy animals or animals being finished for slaughter.

#### USAGE CAUTIONS
