DIRECTIONS FOR USE

To prepare the spray mixture, measure out the required amount of this material and add it to the proper amount of water. Mix thoroughly and apply, agitating continuously. In cold weather this material may deposit a precipi ate in the container. Before mixing in such cases, the material should be warmed gently and agitated until redissolved.

ORCHARDS: Pine Mice, Meadow Mice - For Pine Mice -Use 1½ quarts per 100 gallons of water. For boom application, spray in band 11 feet wide and 670 feet long on each side of a tree row (350 to 400 gallons per acre). For hand-gun application apply 11 gallons of spray to each under-tree area (5½ gallons per side). To penetrate ground cover to reach pine mice trail systems apply at 500 p.s.i. pressure. Specific directions concerning nozzles should be obtained from your State Agricultural Extension Service or Experiment Station. Do not disturb trail systems by cultivation before spraying. Allow minimum of 2 months before cultivating after applying spray. Make post-harvest application during cool periods of autumn. For Meadow Mice - Use 1 quart per 100 gallons of water. Apply 300 to 350 gallons of spray per acre as directed above. Make post-harvest application in October or November. Post treated areas for 30 days following treatment. Do not treat areas where runoff will contaminate water used for domestic purposes, lakes, streams or ponds containing fish. Do not graze treated orchards, cut forage for hay or allow drop fruit to be utilized for any purpose. Application may cause some injury to birds and certain small


