The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped "NOTIFICATION" and placed in our records.

The alternate brand name, "DuPont Nicosulfuron 75 Premix" has been added to the product record.

#### STORAGE AND DISPOSAL

**PESTICIDE STORAGE:** Store product in original container only. Do not contaminate water, other pesticides, fertilizer, food or feed in storage. Store in a cool, dry place.

**PESTICIDE DISPOSAL:** Do not contaminate water, food, or feed by disposal. Waste resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

Then, for Plastic Containers, offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration. Do not burn, unless allowed by state and local ordinances.
