

STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Hold eyelids open and flush with a steady stream of water for 15 minutes. Get medical attention if irritation persists.

Terrazole is useful as a soil fungicide for control of damping-off, root and stem diseases caused by Pythium and Phytophthora. Use only at recommended rates as overdosage may be harmful to sensitive plants. Do not mix with other chemicals, other than Terracion® unless prior use has proven compatibility.

ORNAMENTALS

For bedding and bench plantings use with water as a soil drench at time of seeding and transplanting in commercial nurseries and greenhouses. The drench solution should be continually agitated to assure uniform application of the fungicidal material. To improve penetiation of the fungicide, the drenching should be followed with an equal quantity of water applied either by sprinkling or by irrigation.


