1. Delete the following text from your label:

Controls beetles ... cabbage looper.

These were the sites that you requested to delete.

2. Modify your "Hazards to Humans and Domestic Animals" as follows:

CAUTION

Harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

FIRST AID

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching finger to back of throat. Do not induce vomiting or give anything by mouth to an unconscious person.

- 5. As indicated on Page 37 of the October 1988 Rotenone Standard, submit a revised copy of your Confidential Statement of Formula (CSF). Your most recent one is dated February 15, 1980.
- 6. The current name of the registrant, Agrevo Environmental Health, must appear on the label.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.


