For burrow baiting, apply 1-2 bait packs per burrow.

When baiting burrows, insert each bait pack into the burrow far enough so that only a person who knows that bait is there would be likely to see it. Do not bait burrow in any location accessible to children or nontarget animals unless there is no other way to bait the target population effectively. If burrows in such an area are baited, check burrows every morning and evening to make sure that baits have not become more accessible to children or nontarget animals in any way. Remove packs that become more accessible to nontarget animals. Remove packages of bait from burrow if the bait has not been touched by target rodents for seven days.
