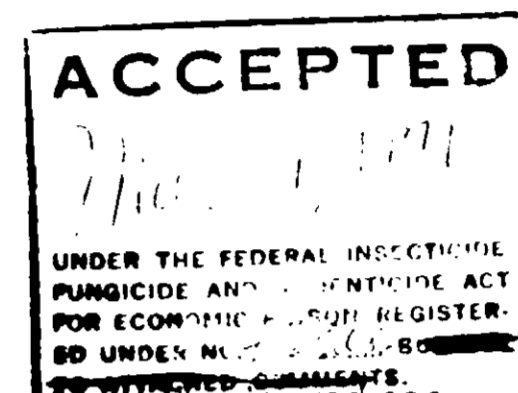

Maneb: Manganese ethylenebisdithiocarbamate	20%

PRODUCT INFORMATION

Use only recommended rates. Lower amounts may not give the desired control. Excessive amounts may cause seed injury. This material is a special seed treatment formulation of Captan, HCB and Maneb which, when used at the correct application rates, protects seeds and seedlings against seed and soil-borne diseases such as seed decay, root rot, damping-off and seedling blight. Also, protection is given against stinking smut of wheat, oats smut, covered and false loose smuts of barely and bunt of rye.

RECOMMENDATIONS and DIRECTIONS FOR USE

PLANTER BOX OR DRILL BOX APPLICATION RATES

Use on seed by mixing with the seed in the box at the rate shown below.

DO NOT MIX WITH HANDS.

Wheat, oats, barley, rye	3 to 6 oz. bu.
Corn seed (field)	3 to 6 oz. bu.
Soybeans, beans, peas	3 to 3 oz. bu.
Peanuts (shelled)	3 to 6 oz. bu.
Cotton	3 to 6 oz. 100#

IMPORTANT: Treated seed must not be used for human consumption nor as animal feed. Bags containing treated seed should be labeled.

TREATED SEED

DO NOT USE FOR FOOD, FEED OR OIL PURPOSES
