**WARNING**

**Hazards to Humans and Domestic Animals**

**Statement of Practical Treatment**

Apply artificial respiration if indicated. **NOTE TO PHYSICIAN:** This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.

**Roaches, Waterbugs, Crickets, Silverfish, Spiders, Scorpions:** Spray baseboards, cracks and crevices, around door and window frames and other hiding places such as closets, in back of and under appliances, sinks and cupboards in the kitchen and bathroom. In basements, spray such hiding places as cracks and crevices, lower walls and dark places.
