**WARNING**

**Hazards to Humans and Domestic Animals**

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. **Statement of Practical Treatment**

**If Swallowed:** Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. **If on Skin:** Wash contaminated clothing and wash affected areas with plenty of soap and water. **If In Eyes:** Flush eyes with plenty of water. Call a physician if irritation persists. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated. **NOTE TO PHYSICIAN:** This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.

This pesticide is highly toxic to fish, birds and other wildlife. Do not apply directly to water or wetlands (swamps, bogs, marshes and potholes). Drift and runoff from treated sites may be hazardous to fish in adjacent waters.
